As you are aware, school districts across the state were informed that Governor Evers has ordered all public and private schools to be closed beginning at 5:00 pm Wednesday, March 18th through Friday, April 3rd. OUSD will be following this order. To continue to support our students we believe it's extremely important to offer breakfast and lunch to students during this extended school closure. It has been amazing to see the community support. The offers of local businesses to provide our students with meals has been heartwarming. We live in a wonderful community!!!

With that being said the government has allowed the district to work through this situation with a waiver for free meals. We will be providing an option for breakfast and lunch to be delivered to all students based on our school bus routes. This service is provided at no cost to you for all children 18 and under.

Monday, March 23 - Food Delivery will begin

Deliveries will be dropped off at your assigned bus stops between 9 am - 11 am. Meals can also be picked up at our in-city distribution sites at OES, OMS, OHS, Holtwood (Ageson Pool), and Howard Lane. Someone must be available to pick up distributed meals at assigned bus stops or in city distribution sites.

If you have opted out of bus transportation you are still eligible for this service. You would alert us or come to an in-city distribution site.

The delivery will include lunch for the current day and breakfast for the following day.

In order for us to prepare, you must fill out the SURVEY by Friday, March 20th at noon to ensure meals are ready for Monday.

Please note all students can receive meals at any location. When filling out the survey please list the way that is most convenient for you. For example, if you are sending your children to a daycare setting or grandma's house and those are located near a distribution site, please list that. Families can go to the school or distribution site nearest them to pick up food even if they do not attend that school. For deliveries, the meal will be brought up to the house. For pick up, families will drive up in the bus loops, and they will be handed meals through the vehicle window.
