The Employability Skills program is designed to provide students with an experience that will enhance their career goals or interests. The rationale for allowing students this opportunity is as follows; to enhance knowledge about current coursework, to explore alternative or related careers, to initiate an interest in a career.

PUPIL NONDISCRIMINATION STATEMENT

The requirements for eligibility for this opportunity are as follows:

- 1. Be on track in terms of credits and grades, including being in "Good Academic Standing".
- 2. Have a limited number of unexcused absences from school in the past three years.
- 3. Have a limited number of discipline referrals in the past three years.
- 4. Completed Employability Skills Agreement.
- 5. Student may receive up to $\frac{1}{2}$ credit for each semester of study, unless other arrangements are agreed upon before the students start the program.
- 6. Administrative approval without prejudice.
- 7. Proof of employment, such as check stub, submitted monthly to Principal/Associate Principal
